Stop @ 37065: somewhat tricky start site. Serine integrase; large pham. Starterator report will not show up. Selected start with best final score; second of two tandem start sites; does result in length (1419) that matches several other AZ members of pham.

Stop @ 43283: chose SS 19 (43098) because it is second of two tandem starts (different from what AZ harmonization team selected, which was mostly SS 18)
